



THE HUTCHINS SCHOOL FEE SCHEDULE 2019

International Students (Years 7–12)

PLEASE NOTE All costs are in Australian dollars. View term dates at www.hutchins.tas.edu.au/term-dates.

Once-only payments

Enrolment fee – \$1,500

A non-refundable enrolment fee is payable per student on acceptance of an Offer of a Place. Short term enrolments (6–12 months) will be charged a \$750 non-refundable enrolment fee.

Capital Fund – \$850

The Capital Fund contributes to the upgrade of student facilities and resources for all students. The Capital Fund fee is non-refundable.

Online English Testing – \$475 (estimate)

As part of the enrolment process students will be required to undertake English testing online. The fee is payable directly to the test provider at the time the test is undertaken.

Health cover – \$2,690 (estimate for four years)

It is a Department of Immigration and Border Protection requirement that Overseas Student Health Cover (OSHC) be paid to the School for the entire length of a student's course. The above estimate is based on the 2018 Medibank Private OSHC Schedule – refer to www.medibank.com.au/oshc or the OSHC policy booklet emailed on confirmation of enrolment.

Ongoing payments (per annum)

Annual tuition fee – \$28,840

Annual boarding fee – \$20,020

The boarding fee includes accommodation and three meals each day, seven days per week during school term time.

Advance Payment Discount

A discount of 3% will apply if the annual tuition and boarding fees are paid in full by 3 February 2019.

Technology levy – \$225

The technology levy helps to facilitate the ongoing provision of required technology hardware, software and systems platforms.

Boarder's activities and pocket money

Tuition fees include \$50 per term to cover weekend and evening recreational activities. Boarders will also need pocket money for miscellaneous expenses when they visit local shops or use Hobart's public transport. Depending on the age of the student, an allowance of approximately \$200 per term is recommended. Boarders' pocket money should not exceed \$20 per week. It is the responsibility of the parents/carers to supply their sons with sufficient pocket money.

Other payments (compulsory)

Uniform – \$1,500 (initial estimate)

Uniforms may be purchased through the School Uniform Store. The estimate above is based on new items. In addition to formal school uniform all boarders need their own personal neat casual clothes and toiletries. Full details will be supplied in the Burbury House (boarding) handbook. Uniforms may need to be replaced during the student's time at the School due to growth, sporting commitments etc. and this will be an additional cost at the time of purchase. Bring Your Own Technology (BYOT) Years 7–8 – \$450 (estimate, Chromebook recommended) Years 9–12 – \$1,500 (estimate, BYOT device)

Students are required to supply their own anti-virus and operating system software. Hutchins supplies Microsoft Office 365 for all enrolled students. For more information refer to www.hutchins.tas.edu.au/learning-with-ict.

A levy is only charged on challenges where interstate or international travel is required.

Other payments (as required)

OPTIONAL Co-operating Schools

Holiday Program – \$102 per night plus activity costs

There is a Co-operating Schools Holiday Program that runs in the April (end of Term 1) and October (end of Term 3) holidays. This program is run for any students that choose to stay in the boarding house during these holidays instead of travelling home. This is not a compulsory program, however, if students decide to be a part of this program, they will be charged additional fees for their accommodation, food and activities.

OPTIONAL Music tuition – \$37 (per lesson)

Music is included at no extra cost in the core curriculum for students up to Year 7. For students in Years 8–12 it is an optional elective subject at no additional cost. Private music tuition is available at \$37 per 30 minute lesson, charged by the teacher.

OPTIONAL Rowing – \$330–\$745 (dependent on the year level)

Charged in Term 3 for the rowing season. The rowing fee covers school regattas and contributes to the cost of the rowing program.

Miscellaneous expenses – charged as required

Students are required to purchase their own text books and stationery from Years 3–12 as listed www.hutchins.tas.edu.au/book-sales.

Depending on requirements and options selected the following may also apply; transport, photos, pharmacy needs, specialist doctors, dentists, tours, Short National Training Courses, bus charges, VET courses, replacement locks, damage to property, lost library books, lost library cards, costumes and sport specific uniforms.

Business Arrangements

By signing the Enrolment Form

parents/carers agree:

1. That the enrolment is subject to the School's acceptance of the enrolment and offering of a place in the School.
2. To pay all Tax Invoices issued by the School for its tuition fees and charges by the due date. Tax Invoices for tuition fees are issued in advance and are due and payable by the first day of term, unless other arrangements have been made (for example monthly direct debit). All other Tax Invoices issued by the School are due and payable immediately. Payments made by credit card will incur a surcharge when paying in person. The surcharge is not applicable to direct debits.
3. Interest will be paid on any overdue amounts owing to the School (including tuition fees, charges and interest) calculated at the Westpac Banking Corporation Indicator Lending Rate, as varied, from the due date until the date of payment in full of those overdue amounts.
4. Non-payment of Tax Invoices may result in the account being lodged with a debt collection agency and all fees and charges incurred as a result of this lodgement will be charged to the account holder.
5. To pay an Enrolment Fee prior to commencement of schooling which shall be determined according to the level of entry, and as specified in the School's Offer of a Place letter.

The Enrolment Fee is payable for each child in the family however will be reduced to 50% of the current fee for the third and subsequent children of any one family.

The Enrolment Fee is non-refundable should the place not be taken up.

The Enrolment Fee is non-refundable.

6. To give at least one term's written notice of withdrawal of the student from the School. If this period of notice is not given, to pay to the School, half of the term tuition fees, calculated at the level at which the student is currently enrolled.
7. To immediately notify the School in writing of any serious illness or disability suffered or developed by the student from time to time.
8. To be bound by the School Rules as amended from time to time.
