



THE HUTCHINS SCHOOL FEE SCHEDULE 2026

International Students (Years 7–12)

PLEASE NOTE All costs are in Australian dollars. View term dates at www.hutchins.tas.edu.au/term-dates.

Once-only payments

Application Fee – \$110

A non-refundable application fee is payable per student application.

Enrolment Fee – \$1,500

A non-refundable Enrolment Fee is payable per student on acceptance of an Offer of a Place. Short term enrolments (6–12 months) will be charged a \$750 non-refundable Enrolment Fee.

Capital Fund – \$850

The Capital Fund contributes to the upgrade of student facilities and resources for all students. The Capital Fund fee is non-refundable.

HSOBA Membership – \$250

A one off fee payable on enrolment (excluding Pre-Kindergarten and Kindergarten) which provides a lifetime membership to the Hutchins School Old Boys' Association (HSOBA).

Health cover – \$5,633 (estimate for six years)

It is a Department of Home Affairs requirement that Overseas Student Health Cover (OSHC) be paid to the School for the entire length of a student's course. The above estimate is based on the 2025 Medibank Private OSHC Schedule – refer to www.medibank.com.au/oshc or the OSHC policy booklet emailed on confirmation of enrolment.

Ongoing payments (per annum)

Annual tuition fee – \$40,600

Annual boarding fee – \$27,720

The boarding fee includes accommodation and three meals each day, seven days per week during school term time.

Advance payment discount

A discount of 3% will apply if the annual tuition and boarding fees are paid in full by 2 February 2026.

Technology levy

- Years 7–8 – \$840
- Years 9–12 – \$620

The technology levy helps to facilitate the ongoing provision of required technology hardware, software and systems platforms. A school owned device is provided to all students in Years 7–8. For more information please refer to www.hutchins.tas.edu.au/learning-with-ict.

Boarder's activities and pocket money

Boarding fees include \$100 per term to cover weekend and evening recreational activities. Boarders will also need pocket money for miscellaneous expenses when they visit local shops or use Hobart's public transport.

Other payments (compulsory)

Uniform – \$1,200–\$1,400

(initial estimate)

Students are required to purchase their own uniform. The estimate above is based on new items purchased through Midford. In addition to formal school uniform all boarders need their own personal neat casual clothes and toiletries. Full details will be supplied in the Burbury House (boarding) handbook. Uniforms may need to be replaced during the student's time at the School due to growth, sporting commitments etc. and this will be an additional cost at the time of purchase.

Bring Your Own Technology (BYOT)

- Years 9–12 – \$1,500 (estimate, BYOT device)

Power of 9 (Year 9)

Boys in Year 9 choose a Challenge as part of their studies for the year. There is an additional charge for challenges involving a significant travel component. The approximate cost per Challenge are:

- Global Challenge – \$5,000–\$5,500
- Port Davey Challenge – \$500
- Indigenous Australia Challenge – \$4,000–\$4,500
- Island Challenge – no charge
- Tasmanian Aboriginal Culture Challenge – no charge

Other payments (as required)

OPTIONAL Music tuition – \$45 (per lesson)

Music is included at no extra cost in the core curriculum for students up to Year 7. For students in Years 8–12 it is an optional elective subject at no additional cost. Private music tuition is available at \$45 per 30 minute lesson, charged by the teacher.

OPTIONAL Rowing – \$675–\$1,355 (dependent on the year level)

Charged in Term 3 for the rowing season. The rowing fee covers school regattas and contributes to the cost of the rowing program.

OPTIONAL School Holiday Boarding Program – \$138–\$165 per night (depending on activities)

The School offers a holiday boarding program for Term 1 and 3 holidays.

OPTIONAL Sports Registration

Depending on the sport selected students may be required to register with the governing body for that sport.

Miscellaneous expenses – charged as required

Students are required to purchase their own textbooks and stationery from Years 7–12 as listed www.hutchins.tas.edu.au/book-sales.

Depending on requirements and options selected the following may also apply: photos, tours, bus charges, lost library books, lost library cards, damage to property, costumes, sports specific uniform, individual sports registration and non-curriculum based excursions.

Business Arrangements

By signing the Enrolment Form parents/carers agree:

1. That enrolment is subject to the School's acceptance of the enrolment and offer of a place in the School.
2. To pay all Tax Invoices for tuition fees issued by the School by the due date. Tax Invoices for tuition fees for Prep to Year 12 tuition fees are issued in advance and are due and payable by the first day of term unless other arrangements have been made (for example monthly direct debit). All other Tax Invoices for school-related fees and charges are due and payable immediately. Payments made by credit card will incur a surcharge when paying in person. The surcharge does not apply to direct debits.
3. To enter into a direct debit arrangement with the School for the payment of tuition fees for Pre- Kindergarten, Kindergarten and Outside School Hours Care. Statements are issued fortnightly and direct debit payments are processed in arrears. Parents/carers may access Child Care Subsidy (CCS) from the government for these services.

4. That interest will be paid on any overdue amounts owing to the School (including tuition fees, charges and interest) calculated at the ANZ Indicator Lending Rate, as varied, from the due date until the date of payment in full of those overdue amounts.
5. That non-payment of Tax Invoices may result in the account being lodged with a debt collection agency and all fees and charges incurred as a result of this lodgement will be charged to the account holder.
6. To pay an Enrolment Fee and Hutchins School Old Boys' Association Lifetime Membership Fee before the commencement of schooling as specified in the School's Offer of a Place letter (excluding Pre-Kindergarten and Kindergarten). The Enrolment Fee is payable for each child in the family but will be reduced to 50% of the current fee for the third and subsequent children of any one family. The Enrolment Fee is non-refundable even where the place is not taken up.
7. To give at least one term's written notice of withdrawal of a student from the School. Notice must be given by the 1st day of Term 1 or withdrawal at the end of that term. If this period of notice is not given, the remaining balance of the current term plus half of the tuition fees for the following term is due and calculated at the level at which the student is currently enrolled.
8. To immediately notify the School in writing of any serious illness, concussion or disability suffered or developed by the student.
9. To be bound by the School Rules as amended from time to time.
